### Evaluator's Instructions to the Candidate

At this station, you will be provided with a HazMat Incident Worksheet with 1 of 3 scenarios, and an Incident Action Plan corresponding to that specific scenario. You will be required to complete the ENTIRE worksheet utilizing the Incident information, the IAP and information you attain from the ERG. You are a first responder arriving on the scene and in command until relieved by a higher ranking officer.

Lastly, you will need to provide a verbal update report on the scenario to the incoming Incident Commander (IC) who arrives on scene to relieve you.

The evaluator will act as the incoming IC arriving on scene.

## **Skill Set: Demonstrate Emergency Decontamination**

Candidate Equipment Required: Complete NFPA-Compliant Personal Protective Clothing Ensemble with SCBA and PASS device, ERG

Evaluator Equipment Required: Salvage tarp, 1-3/4" hoseline with nozzle, empty 5 gallon bucket

### **Evaluator's Instructions to the Candidate**

At this station, a firefighter wearing full PPE and SCBA is returning from a simulated HazMat Hot Zone and requires emergency decontamination. The evaluator will inform you what contaminant the firefighter was exposed to.

You will be the Decontamination Team leader and the evaluator will act as a team member. The evaluator will only acknowledge and perform the tasks you assign them within their abilities as an Operations level responder.

You are required to demonstrate all steps necessary to perform emergency decontamination of the firefighter. Once completed, you will transfer the firefighter to EMS treatment personnel.

Once emergency decontamination is completed, the evaluator will act as the EMS treatment personnel to transfer the firefighter over to.

# Skill Set: Mission-Specific Competencies PPE: Don, Work In, and Doff PPE & SCBA

Candidate Equipment Required: Complete NFPA-Compliant Personal Protective Clothing Ensemble with SCBA and PASS device

Evaluator Equipment Required: None

### Evaluator's Instructions to the Candidate

At this station, you will be required to don a personal protective clothing ensemble (PPE), including SCBA. Each candidate will begin this station fully dressed (including shoes/boots) in street clothes/station uniform. The exact sequence of donning the PPE and SCBA is not graded. However, once completed, all components must be correctly worn. <u>You will have three (3) minutes to complete the donning process.</u> When you have completed all donning procedures, clap your hands and an evaluator will inspect you.

Once you have completed the donning portions of this station, the evaluator will give you a work assignment to complete. Once the assignment is complete, you will DOFF the SCBA and your PPE and make the ensemble ready for use.

### **Evaluator's Instructions to the Candidate**

At this station, you will be provided with an image of a HazMat incident Worksheet. Each worksheet has a different scenario.

After reading the scenario, complete <u>all</u> portions of the HazMat Incident Worksheet as if you are the first responder arriving on the scene and currently in command until you are relieved by an officer of higher rank.

Some of the items to consider include - but are NOT limited to - level of PPE & respiratory protection required, chemical name, ID#, container type, method(s) of controlling the product, etc.

Once complete, the evaluator will act as the incoming officer and you will communicate a scene summary to them with all the necessary information about the incident following policies and procedures.

# Skill Set: Mission-Specific Competencies Product Control: Product Control Techniques

**Evaluator Equipment Required:** 1-3/4" hoseline with nozzle, absorbent material, absorbent pads/booms, push broom, shovel, empty 5 gallon bucket

### **Evaluator's Instructions to the Candidate**

At this station, you will be provided the appropriate tools and equipment to mitigate a *"simulated"* HazMat release situation. You will be required to demonstrate/perform product control techniques. You will be responsible for demonstrating all procedures for product control currently expected of a first responder at the Operations level.

The evaluator will indicate which four (4) of the seven (7) skills listed below that you will demonstrate. You must also identify what level of PPE would be necessary for the skills chosen.
