AFFIDAVIT

STATE OF IOWA, HARRISON COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 4/21/2024, Sebastin O'Brien was operating Douglas Manley's pickup on Austin Avenue south of Modale in Harrison County. Sebastin crashed the pickup after which he was picked up by Steve Baker and driven to Modale. Steve and Sebastin got into a physical confrontation which was reported to the Sheriff's Office. Sheriff's Deputies found Sebastin in Modale. Sebastin was combative with Deputies. Sebastin was intoxicated and made unsolicited statements indicating he had assaulted the owner of truck. Due to Sebastin having been operating Douglas's pickup, law enforcement went to Douglas's residence at 1505 305th Street in rural Harrison County. Deputy McMurray arrived and found tire tracks in the driveway which appeared someone left in a hurry. Blood was smeared on the front door window. The front door appeared to have been forced open. Deputy McMurray entered the home and found more blood inside the residence. Douglas was found deceased at the top of the stairs to the upper floor. Douglas had severe blunt force facial and head injuries.

In an interview at the Missouri Valley Hospital. Sebastin stated he and Douglas drove to the residence from DeSoto Bend to move furniture at Douglas's residence. Douglas and Sebastin had been living together in a camper by DeSoto Bend. While moving furniture, the two got into a physical confrontation. Sebastin stated he punched, kicked, and struck Douglas with dresser drawers. Sebastin stated Douglas deserved it because he had been trafficking children in Blair, NE. Sebastin stated he was raped by Douglas earlier in the day.

After his arrest, Sebastin called his mother and told her Douglas deserved to die because he had been molesting "Brenda".
