#### **Note From the SWIC**

The devastating tornadic weather in Greenfield was shocking to witness; that amount of destruction is almost unfathomable. ISICS communications did remain intact though the tower was in the direct path and did take significant damage, the built-in resiliency of the system prevailed. ISICS cache radios and chargers were deployed as local equipment was lost with the storm. Iowa weather does not give its citizens any sort of summer vacation, and the flooding in NW Iowa has caused horrible devastation. Numerous interoperable resources have been deployed to Spencer for communications relief including the Disaster Recovery PSAP, West STR, ISICS cache radios, and chargers. Together we will weather this storm.

Story County hosted the Communications Exercise in June, and I would like to give a heartfelt and abundant thank you to everyone who was involved in this event for dedicating your time, efforts, and resources to train personnel for the communications unit of Iowa. Over 2 days of exercise, we had 23 individuals from 10 agencies across the state work towards tasks to improved skills in their specific communications unit discipline. There were also well over 20 volunteers to evaluate these trainees, work in the simulation cell as dispatchers, and set up the deployable resources. Thank you to their agencies for allowing their participation. This event fostered teambuilding, interoperable communications and knowledge sharing; the volunteer response was amazing.

A special thank you to our friends and neighbors in Story County, especially Sheriff Fitzgerald and his amazing staff, and Nic Briseno who helped coordinate this entire event. They welcomed us in and gave us the run of their home for a successful event with true interoperable communications partners.

## New Incident Tactical Dispatcher (INTD) All-Hazards Credentials

During the June 13, 2024, ISICSB Meeting, SWIC Haley Nichols presented the following individuals with their Incident Tactical Dispatcher (INTD) credentials.

An INTD is a specially trained individual qualified to operate away from the dispatch center in a command post, base camp, or at the incident scene. INTDs leverage the multi-tasking, communication, accountability and documentation skills of successful telecommunicators to provide public safety communications expertise and support at planned events and extended incidents such as hostage situations, multi-alarm fires, search and rescue operations, bombings, and active shooter incidents.



Jason Hoffman was also presented with his Communications Leader (COML). A COML's responsibilities include developing plans for the effective use of incident communications equipment and facilities, managing the distribution of communications equipment to incident personnel, and coordinating the installation and testing of communications equipment.
