Welcoming Remarks: Vice-Chair Updike welcomed everyone and thanked them for attending.

Approval of Agenda: Curtis Woten motioned to approve today's agenda. Mindy Benson seconded the motion. All in favor. Motion passes.

Approval of Minutes: David Ness motioned to approve the May ISICSB Meeting Minutes. Travis Solem seconded the motion. All in favor. Motion passes.

SWIC Report: SWIC Haley Nichols reports the following:

- Story County COMMEX is June 19th & 20th
- Central States COMMEX in September 10-13, 2024, in Joplin, MO
- Final edits are in progress and will be submitted to the contractor soon
- Attended the Cyber Resilient 911 Symposium for information on cyberattacks and preparedness – below are the key takeaways include the following:
 - Not if, but when everyone should be focusing on their PACE planning but also their recovery plan, be prepared to work in an environment without your dedicated technology for a possibly extended period of time, train on this – build your relationships across systems across departments early
 - It's about being able to recover fast and efficiently with the least amount of disruption and stress
 - It's about resiliency
- Attended NCSWIC in Mobile, AL
 - Some topics discussed include Artificial Intelligence, Interoperability, FirstNet, the future of TA requests
 - SWIC Nichols and Chris Maiers gave a presentation on a Swatting poster that was recently created
 - NCSWIC Committee shared several videos (What is a SWIC, What are Emergency Communications, and What is Interoperability). SWIC Nichols encourages everyone to watch them.  - In conjunction with the REMCDP project and the O-Rap project that has been ongoing in Carroll County for over a year, Regional Communications Enhancement Support Project (RCES) has begun. This is a strategic communication migration plan.
 - As the work progresses on the REMCDP, the State of Iowa Emergency Medical Services Communications Plan will be updated
- Attended a webinar by Mission Critical Partners on safeguarding mission-critical public safety infrastructure (including LMR systems) from cybersecurity threats

911 Council Report & E911 Program Manager: In the absence of 911 Program Manager Blake DeRouchey, Kayla Beckerdite gave the 911 Council report. Kayla introduced herself as a new support person for the Iowa HSEMD 911 program and the Alert Iowa program.

Kayla reports that the Council met, and the primary topic of discussion was focused on the recent Lumen outage that significantly affected several PSAPs across the state of Iowa.

User Group Committee (UGC): UGC Chair Hess reports the Committee met and reviewed one updated user application that is up for approval today under New Business.

Finance Report: The monthly net expenditures for May 2024 for the Interoperable and Broadband Communications Fund were \$12,306.37. The remaining amount available is \$67,478.27.

Governance Committee: Governance Chair Ness reports that the Committee met and reviewed and made minor edits to ISICS Standards 4.2.0 and 4.5.0. Since the edits were non-substantial, no Board action is needed. The Committee also discussed ISICS Standard 7.1.0 – Standards Compliance Process. The group felt it was necessary to further discuss this standard with Chair Bischof, system administrators, and other committees to clarify direction on the stated evaluation process.

Operations Committee: SWIC Nichols reports the Committee met and discussed the standard being worked through the REMCDP working group. No further edits were made, and it is up under New Business for approval to post for 30-day public comment.

Training & Outreach Committee: Training & Outreach Committee Chair Solem reports the Committee met and discussed the following:

- Work continues on whitepapers regarding the following:
 - Radio Basics
 - Affiliation and Scanning
 - Patching

Technology Committee: Technology Chair Updike reports the Committee met and continues to work on ISICS Standard 2.4.1 – Bi-Directional Amplifiers. Chair Upike is adding information to address registering Class A and Class B amplifiers. Class B amplifiers are required to be registered with the FCC; Class A are not required to register. A standard requiring users to register for both Class A and Class B would allow the system administrators to develop a running database to use in case there are any problems.

Other unfinished business that the Committee has been working on include the following:

- Still waiting on the 6 additional frequencies to add to the ITALK list once the licensing is complete, the ICS-217A will be updated
- Develop plan within the RPC to lay out how the 800 MHz frequencies are used throughout the state – this is needed in order to add it to the ICS-217A Scene of Action Channel Plan
- ISICS Standard 3.11.0 Talkgroup Site Access and Roaming
- Discipline-Specific Encryption

FirstNet Broadband Subcommittee: FirstNet Subcommittee Chair Benson reports the Subcommittee met and discussed the following:

- Lumen outage discussion
