I, the undersigned, being duly sworn, that all facts contained in this Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On February 17th, 2024, this Agent was assigned to investigate the death of Brianne McIntosh after her body was found in rural Fremont County Iowa. Through investigation, which consisted of an autopsy, interviews, search warrants, and phone downloads, it was determined that Justin SICKLER murdered Brianne McIntosh at his apartment located at 319 North 1st Street in Council Bluffs, Iowa, on or about December 5, 2023, with premeditation and/or while participating in a forcible felony; i.e., sexual abuse and/or willful injury causing serious injury.

Records obtained from Brianne McIntosh's Google account revealed that at 8:58 PM on the night of December 5, 2023, she used Google Maps to obtain directions to SICKLER's apartment at 319 North 1st Street, Council Bluffs, Iowa. In an interview with SICKLER, he admitted that McIntosh spent that night at his apartment. McIntosh was never heard from or seen again by any of her friends or family after December 5th, 2023. McIntosh was very active on several social media platforms and as of the night of December 5th, 2023, all communications by her on these media platforms ceased. McIntosh was 28 years old at the time of her death.

On December 7th, 2023, SICKLER concealed McIntosh's body by transporting her to a dead-end dirt road in rural Fremont County Iowa where he dumped her body in a steep ditch. SICKLER was on probation during this time frame with the Iowa Department of Corrections and was wearing an ankle monitor. SICKLER's GPS from his ankle monitor showed that on December 7th, 2023, SICKLER drove to the exact location in Fremont County Iowa where McIntosh's body was found. This is a very remote location with little to no traffic. According to GPS records, SICKLER was at that remote location for two minutes and then returned back to his apartment in Council Bluffs. In an interview with SICKLER, he stated that he drove McIntosh to rural Fremont County and then back up to Council Bluffs where he dropped McIntosh off at her mother's address. According to GPS records, SICKLER never drove by or stopped at her mother's address on his way back up to his apartment in Council Bluffs from Fremont County. In an interview with SICKLER, a question was posed to SICKLER that if Law Enforcement found any surveillance footage from that morning what would it show? SICKLER stated that it would show McIntosh lying down in his car, then he stated, not lying down but leaning relaxed against the door, sleeping. SICKLER not only places McIntosh in his car on or about December 7, 2023, and appearing unconscious, but a search warrant of his vehicle revealed a large section of the back seat was cut out with a sharp object, and the foam removed. SICKLER stated it was McIntosh's idea to go to Fremont County. SICKLER stated McIntosh woke up on the drive to Fremont County to tell him where to go, as if she had been there before. McIntosh's phone reveals no GPS or other searches related to Fremont County, and no activity whatsoever after December 5, 2023. Throughout this investigation Law Enforcement has found no connection between McIntosh and rural Fremont County. In contrast, investigation revealed that SICKLER has substantial connections to Fremont County and the surrounding area. According to GPS records, SICKLER has taken the exact route he took on December 7th, 2023, to dump McIntosh's body at least four other occasions prior to December 2023, on his way to Shenandoah, and it appears he knows the area well. SICKLER is originally from the Shenandoah area, including Fremont and Page County.

McIntosh's body was not discovered until February 17th, 2024. When McIntosh's body was discovered, an autopsy was performed. The pathologist was not able to determine her cause of death due to the degree of decomposition, but the autopsy did reveal that McIntosh sustained severe facial trauma at or around the time of her death. The pathologist was also able to rule out any illness or disease that would have caused McIntosh's death. In an interview with SICKLER, he admitted that he liked McIntosh but he barely knew her, he had only given her a couple rides with his car. Through cell phone records, it was discovered that SICKLER had messaged McIntosh more than 300 times between October 22nd, 2023, and December 7th, 2023. The content of those messages is no longer available. In an interview with SICKLER, SICKLER advised that when McIntosh arrived at his apartment on December 5th, 2023, she had several cell phones and a "wad of cash rolled up" (SICKLER estimated several hundred dollars). During this investigation, investigators discovered images on SICKLER's cell phone that were taken of McIntosh in SICKLER's apartment that show her fully clothed on December 5th, 2023. McIntosh is not looking at the camera nor does she appear in the images to be aware that photos/video of her are being taken. At the same time the photos were being taken, SICKLER was using his phone to view pornographic material involving sex with what appears to be an unconscious person. SICKLER is a registered sex offender. SICKLER stated in an interview that McIntosh had several belongings with her on December 5, 2023. When McIntosh's body was found, the surrounding area was carefully searched and none of her belongings were found. McIntosh's body was found completely nude from the waist down, but wearing the same black sweatshirt that she is depicted wearing in the photographic images taken with SICKLER'S phone on December 5, 2023. SICKLER'S apartment was the last location where McIntosh was known to be in possession of her property. Her property was not found during a search warrant of SICKLER'S apartment, despite the fact that both her phone records, his photography with his own phone, and his own admissions place her at his apartment on December 5, 2023. SICKLER was in a position to have taken unlawful possession of McIntosh's property and dispose of it contrary to her right to her property. SICKLER hid McIntosh's body or failed to disclose the known location of McIntosh's body, with the intent to conceal the theft of her property, and/or his assault upon her.

During this investigation, Investigators discovered images on SICKLER's cell phone that were taken of McIntosh in Sickler's apartment that show her fully clothed on December 5th, 2023. McIntosh is not looking at the camera nor does she appear in the images to be aware that photos/video of her are being taken. At the same time the photos were being taken, SICKLER was using his phone to view pornographic material involving sex with what appears to be an unconscious person. SICKLER is a registered sex offender. SICKLER stated in an interview that McIntosh had several belongings with her on December 5, 2023. When McIntosh's body was found, the surrounding area was carefully searched and none of her belongings were found. McIntosh's body was found completely nude from the waist down, but wearing the same black sweatshirt that she is depicted wearing in the photographic images taken with SICKLER'S phone on December 5, 2023. SICKLER'S apartment was the last location where McIntosh was known to be in possession of her property. Her property was not found during a search warrant of SICKLER'S apartment, despite the fact that both her phone records, his photography with his own phone, and his own admissions place her at his apartment on December 5, 2023. SICKLER was in a position to have taken unlawful possession of McIntosh's property and dispose of it contrary to her right to her property. SICKLER hid McIntosh's body or failed to disclose the known location of McIntosh's body, with the intent to conceal the theft of her property, and/or his assault upon her.
