## Note From the SWIC

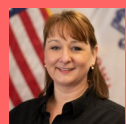

## DPS Employee of the Month



Congratulations to Interop Communications Engineer, Dave Brittain, on being selected the DPS Employee of the Month for December.

Dave began his DPS career in 2008 when he joined the Interoperability Bureau as a Communications Engineer. Since then, Dave has contributed to the Interoperability Bureau by managing talkgroup and encryption development. He has spent significant time and effort ensuring radio IDs can be used on the statewide platform and assisting all agencies with radio ID and talkgroup fleet mapping.

Dave was also largely responsible for creating a unified talkgroup that allowed DNE, DOI, ISP, drug task forces, narcotics units, ATF, FBI, DEA, US Marshals Service, Homeland Security Investigations, and US Postal Inspection Services to communicate seamlessly with one another on their department-issued radios anywhere in Iowa. The Task Force Zone is available 24 hours a day and 365 days a year on ISICS. This capability never existed prior to Dave's efforts and represents an innovation that was not only decades in the making but has revolutionized communication among those conducting drug investigations.

## ISICS System Administrator Reports

### October 2024

Radios = 40,412 (up 571 from September 2024)

Talkgroups = 3,424 (up 13 from September 2024)

Push-to-Talks = 3,072,522 (up 129,262 from September 2024)

### November 2024

Radios = 41,280 (up 868 from October 2024)

Talkgroups = 3,424 (no change since October 2024)

Push-to-Talks = 2,758,022 (down 314,500 from October 2024)
