I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed his crime

State all facts and persons relied upon supporting elements of alleged crime

On or about December 6, 2024, and continuing thereafter, the defendant, while knowingly and unlawfully using the social media platform Snapchat, transmitted explicit images depicting genitalia to a person under the age of 18. The first transmission occurred while the defendant was on duty at the Eagle Grove Police Department, and the second transmission occurred while off duty in a private setting. The defendant acted with knowledge that the recipient was a minor and did so in violation of Iowa Code 728.2.
