Yes. The rule clearly defines the colors and design of the standard uniform for the sheriffs and deputy sheriffs in Iowa, ensuring consistency and conformity on the county level throughout the state.

**Yes.** The public is able to distinguish sheriffs and sheriff's deputies from other law enforcement agencies and officers of the state. This rule also provides for consistency among uniforms at the county level.

CHAPTER 3  
SHERIFF'S UNIFORMS

**661—3.1(17A,331) General provisions.** These rules are adopted to designate the color and design of the standard uniform and accessories for Iowa sheriffs and deputy sheriffs.

**3.1(1)** The specifications of the uniforms and accessories, such as fabric and style, are made available to the department of administrative services.

**3.1(2)** Persons wanting to enter bids on the sheriffs' uniforms and accessories should contact the department of administrative services.

**661—3.2(17A,331) Uniform.** The uniform generally consists of:

(a) Sage green trousers with a one-inch strip of material the same color as the shirts down the outside seam of each pant leg.

(b) Long sleeved or short sleeved shirts with two-breasted pockets pleated with three-pointed flags and shoulder ornaments made of the same material and color as the trousers.

(c) Four types of hats. The winter and summer hats are sage green with a swivel strap, three-inch brims. The winter hat has a gold metallic acorn cord. The summer hat has a metal eyelet for a badge. The winter fur hat is sage green with sage green fur trim. A baseball style cap can be sage green or match the shirt.

(d) Sage green ties that are three and one-half inches at the widest point.

(e) Black, round-toed shoes and boots.

(f) Two types of jackets. A sage green light duty jacket and a forest green/reversible to international orange or safety yellow raincoat.

(g) Accessories consisting of shoulder and blazer emblems, badges, name bar, tie accessories, and rank insignia.
