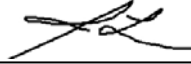
AFFIDAVIT**STATE OF IOWA, DALLAS COUNTY**

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that he defendant committed his crime

State all facts and persons relied upon supporting elements of alleged crime

On or about January 21, 2025, at an unknown time, the defendant transported A.H, a 14 year old female, to the Super 8 Motel, located in Perry, Dallas County, Iowa, with the intention to sell A.H. into commercial sexual activity. Upon arrival, the defendant engaged with her co-defendant to discuss the price to have A.H. engage in sexual activity while in a hotel room.

According to review of the evidence, A.H. captured the conversation between the Defendant and co-defendant. During the conversation, the co-defendant and defendant agree on a price for the co-defendant to sexually engage with A.H. Accordingly, the Defendant while engaged in a venture did unlawfully transport the victim, and did agree to sell the victim into commercial sexual activity.
