Throughout those transactions BENWARD changed his outfit multiple times, used MCKEE, and went to different tellers in order to break up transactions totaling \$12,850. Transactions that are \$10,000 or greater are required to be reported to the IRS. This activity was witnessed on video by Special Agent JOSH DAGIT and surveillance director VINCE FURY.
