Candidate Equipment Required: Complete NFPA-Compliant Personal Protective Clothing Ensemble

Evaluator Equipment Required: 2-1/2" hoseline and nozzle; Spanner wrenches; Hose tester or pumper apparatus; chalk or marker

Skill Objectives: Perform an annual service test on fire hose.

Skill Instructions: Given PPE (minimum utility gloves, helmet, & eye protection), hose testing pump, fire hose, and other necessary tolls & equipment, the candidate will follow procedures to perform an annual test on fire hose, evaluate the condition of the hose, remove damaged hose from service, & verbalize documentation procedures.

Candidate MUST successfully be competent in each of the steps listed to pass this skill station.
