MINUTES OF REGULAR MEETING HELD JANUARY 20, 2026

The Board of Trustees of the Peace Officers' Retirement, Accident & Disability System convened on January 20, 2026, at 2:00 p.m. Members of the Board present and constituting a quorum were Chairman Stephan Bayens, Trustee Roby Smith (Remote), Trustee Mark Oiler, Trustee Marland Winter, and Trustee Seth Bean. Item 1 - Approval of minutes from POR Board meeting held December 15, 2025

Trustee Bean made a motion to approve the minutes. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 2 - Application for Service Retirement – Mark Weidman

Special Agent Mark Weidman with the Division of Criminal Investigation applied for service retirement effective March 13, 2026. He elected Option #5, the Joint and 75% Survivor Annuity. Trustee Bean made a motion to approve the application for service retirement. Trustee Winter seconded. The motion carried by unanimous voice vote.

The motion carried by unanimous voice vote.

Item 7 – Request for Medical Expense Reimbursement – Kirk Nielsen

Accidental disability retiree Kirk Nielsen submitted documentation for reimbursement of \$373.48 in medical expenses not paid by his health insurance. Trustee Winter made a motion to approve payment of \$373.48 for reimbursement of expenses directly related to Kirk Nielsen's disabling condition. Trustee Bean seconded. The motion carried by unanimous voice vote.

Item 8 – Request for Medical Expense Reimbursement – Dennis McMahon

Accidental disability retiree Dennis McMahon submitted documentation for reimbursement of \$325.00 in medical expenses not paid by his health insurance. Trustee Bean made a motion to approve payment of \$325.00 for reimbursement of expenses directly related to Dennis McMahon's disabling condition. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 9 – Quarterly Performance Report – September 30, 2025 – Treasurer's Office

Treasurer of State's Office provided the quarterly performance report for July, August, and September 2025. Trustee Bean made a motion to accept the quarterly performance report dated September 30, 2025. Trustee Oiler seconded. The motion carried by unanimous voice vote.

Trustee Smith made a motion that PORS transition its investment strategy with Fisher from the “Small Cap Value” strategy to the “Small and Mid-Cap Core” strategy with a benchmark against the Russell 2500 Index. Chairman Bayens seconded. The motion carried by unanimous voice vote.
