MINUTES OF REGULAR MEETING HELD JUNE 15, 2026

The Board of Trustees of the Peace Officers' Retirement, Accident & Disability System convened on June 15, 2026, at 2:00 p.m. Members of the Board present and constituting a quorum were Chairman Stephan Bayens, Trustee Seth Bean, Trustee Mark Oiler (Remote), Trustee Roby Smith (Remote), and Trustee Marland Winter (Remote). Members of the Board absent were none. Others present were POR Legal Counsel John Lundquist (AG's Office), Sue Cave (SPOC, remote), Erin Kokemiller (Senate Republicans), Xavier Leonard (LSA), and Molly Widen (TOS). DPS staff present were POR Board Secretary Jasmine Cripps, and POR Recording Secretary Amanda Veren.

Item 1 - Approval of Minutes from POR Board meeting held May 18, 2026

Trustee Bean made a motion to approve the minutes. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 2 – Approval of Closed Session Minutes from POR Board meeting held May 18, 2026

Trustee Bean made a motion to approve the closed session minutes. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 3 - Application for Service Retirement – Michael Kober

Captain Michael Kober applied for service retirement effective June 26, 2026. Trustee Bean made a motion to approve the application for service retirement. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 4 - Application for Vest Service Retirement – David Schipper

Vested POR member David Schipper applied for vested service retirement effective August 12, 2026 and elected Option #6, the Joint & 100% Survivor Annuity. Trustee Bean made a motion to approve the application for vested service retirement. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 5 – Request for Medical Expense Reimbursement – Ward Crawley

Accidental disability retiree Ward Crawley submitted documentation for reimbursement of \$502.05 in medical expenses not paid by his health insurance. Trustee Bean made a motion to approve payment of \$502.05 for reimbursement of expenses directly related to Ward Crawley's disabling condition. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 6 – Treasurer's Office Monthly Reconciliation – January through March 2026

Treasurer of State's Office provided the quarterly reconciliation report for January, February, and March 2026. Trustee Bean made a motion to accept the Treasurer's Office monthly reconciliation report for January, February, and March 2026. Trustee Winter seconded. The motion carried by unanimous voice vote.

Item 7 – Retired Trustee Election Results – POR Staff

The final votes in the POR Board of Trustees election for representation of the retired membership concluded at the end of May. Marland Winter had the highest number of votes and agreed to retain his seat on the POR Board for the next two-year term beginning July 1, 2026.

Item 8 – Open Forum

POR Board Secretary Jasmine Cripps advised the Board an application for accidental disability was received for Trooper Tyler Shiels. An update will be provided after the medical records are submitted to the POR Medical Board.
