### Item 1 - Approval of minutes from POR Board meeting held December 18, 2023

### Item 2 - Application for Service Retirement – Mark Miller

Captain Mark D. Miller with the Iowa State Patrol applied for service retirement effective February 3, 2024. He elected Option #6, which is the Joint & 100% Survivor Annuity. Trustee Metzger made a motion to approve the application. Trustee Conrad seconded. The motion carried by unanimous voice vote.

Accidental disability retiree Kirk Nielsen submitted documentation for reimbursement of \$400.31 in medical expenses that were not paid by his health insurance. Trustee Metzger made a motion to approve payment of \$400.31 for reimbursement of expenses directly related to Kirk Nielsen's disabling condition. Trustee Conrad seconded. Motion carried.

### Item 4 - Application for Medical Expense Reimbursement – Ward Crawley

Accidental disability retiree Ward Crawley submitted documentation for reimbursement of \$215.13 in medical expenses that were not paid by his health insurance. All expenses are for the types of items that have previously been approved for reimbursement to other disability members for the same type of disabling condition. Trustee Metzger made a motion to approve payment of \$215.13 for reimbursement of expenses directly related to Ward Crawley's disabling condition. Trustee Conrad seconded. Motion carried.
