Item 1 - Approval of minutes from POR Board meeting held August 15, 2022

Trustee Conrad made a motion to approve the minutes. Trustee Metzger seconded. Motion carried.

Item 2 - Application for Vested Service Retirement – Jeffrey Herter

Mr. Jeffrey Herter has submitted an application for vested service retirement. Vested members may allow contributions to remain in the system and receive a retirement service allowance upon reaching age 55 in accordance with Iowa Code 97A. Item 7 - Quarterly Performance Report – June 30, 2022 – Jina Bresson, Treasurer's Office.

The Board was provided the quarterly performance report from the Treasurer of State's Office for April, May and June 2022. PORS 6/30/2022 market value was \$624,315,725. The rate of return for the PORS Fund was -14.48% (before fees) for the quarter and an annual return of -21.47% for the one-year period. Large cap manager

Jennison was down -26.38% for the guarter. Index manager Vanguard was down -16.82% for the guarter. Small cap manger Fisher was down -21.00% for the quarter. Loomis Sayles was down -4.66% for the quarter. Lazard was down -4.25% for the guarter. International equities manger Baillie Gifford was down -17.07% for the quarter. Principal US Property was up 3.01% for the quarter. Principal Enhanced was up 5.12% for the quarter. Trustee Conrad made a motion to accept the quarterly performance report. Trustee Metzger seconded. Motion carried.

Item 8 - Open Forum

Trustee Metzger inquired about the portability between the MFPRSI (411) system and the POR system and its impact to the POR system. Chairman Bayens advised that actuary Pat Beckham recently looked into this and found the impact to the system to be negligible. He also stated that Pat would be here for next month's meeting and could speak more about it at that time and if possible it would be interesting to find out what the impact to the fund would have been had we not allowed the transfers to come into the POR system.
