- The investment addresses one of public safety's top critical communication priorities: in-building coverage.
- The agency-deployed RAN extension services leverage state-of-the-art small cell technology and include Band 14 support.
- This investment supports the expansion of Band 14 coverage where public safety operates indoors, such as at police headquarters, a fire station, ECC, or EOC.
- The small cell technology can be used anywhere with a broadband connection.



- Agency-deployed RAN is an effective way for public safety to place FirstNet coverage where and when they need it, with access to all the features and functions of the network.

Why not use Wi-Fi?

- Agency-deployed RAN gives public safety all the priority and benefits of the FirstNet network (Band 14, QPP, MCS). Wi-Fi does not.

How much is FirstNet investing in small cells for agencies to deploy?

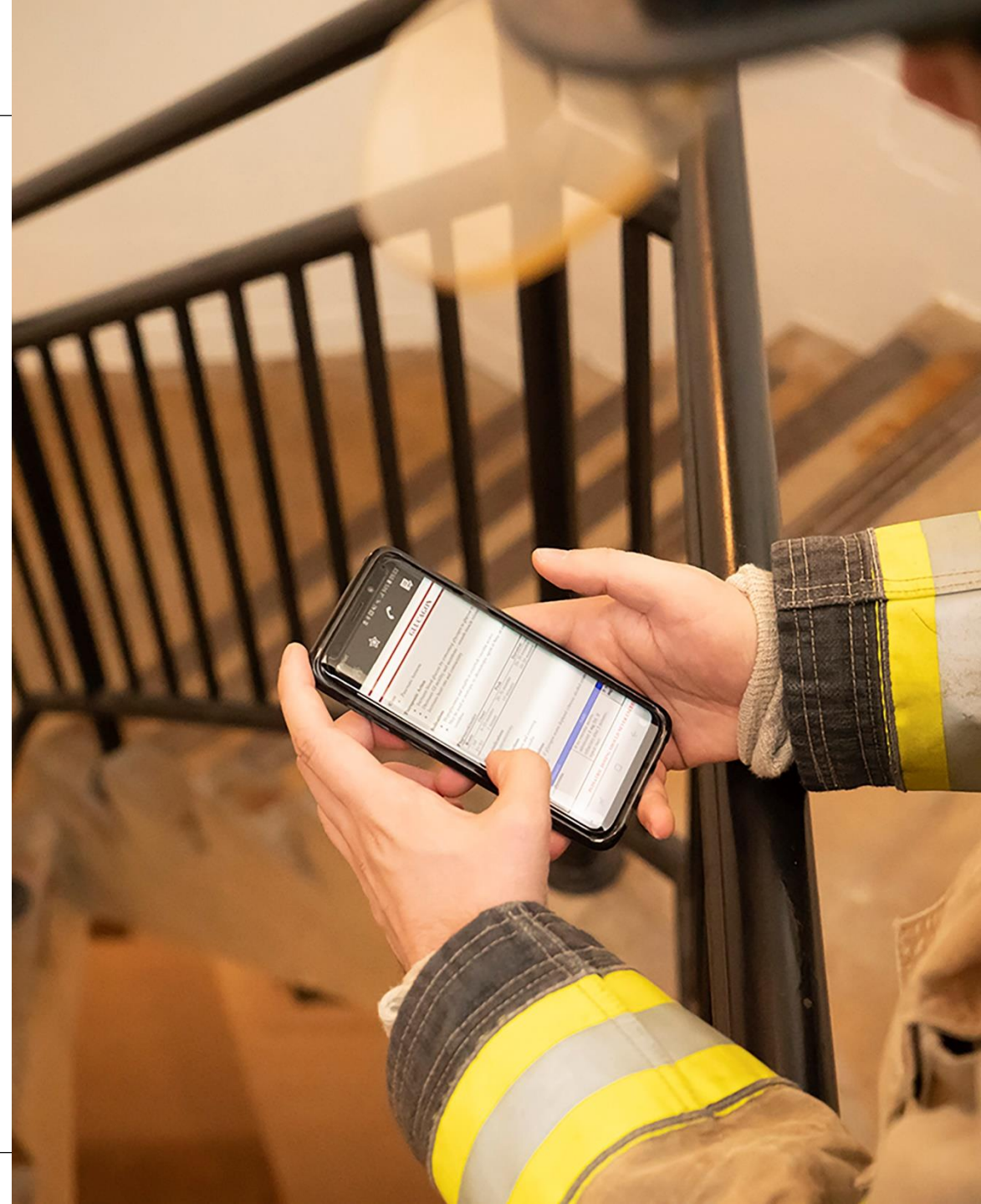
- This is a multi-million dollar investment; the FirstNet Authority is funding a service to expand in-building coverage.

Who gets access to this program?

- FirstNet **primary** agencies.

How it works

- Working through AT&T, a primary agency subscriber can install up to 50 AT&T Cell Booster Pro devices—at no cost to the agency.
- The Cell Booster Pro provides ~15,000 sq. feet of coverage. A maximum of 3 Cell Booster Pro devices can be deployed in a single location, providing coverage to a facility with up to 45,000 sq. feet of space.
- The Cell Booster Pro supports communications for devices operating on 700 MHz Band 14 (the spectrum licensed to the FirstNet Authority) and Band 2 (spectrum for AT&T's commercial network).
