I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

been 14 years old at the time. The Defendant is the victim's step-grandfather.

The Defendant committed this offense while they were staying in a room at the Hilton Garden Inn (205 S. 64th St. in West Des Moines, Dallas County, IA) in 2016. The Defendant encouraged the victim to watch pornography on his phone in the bathroom of the Defendant's room and masturbate. The victim did this with the door closed. The Defendant tried to force the door open and enter, but was not able to. The Defendant reached his arm into the bathroom attempting to touch the victim's erect penis, but the victim was able to move out of the way. Afterwards, the Defendant asked the victim if he had ejaculated.

The Defendant starting asking the victim questions about his masturbation schedule and penis size after he hit puberty. The Defendant would also wake the Defendant up by pulling down his shorts and asking him if he had morning wood. This occurred around 7th-8th grade. The Defendant is being charged in Polk County for sexual abuse 3rd for this incident as it occurred at the victim's residence in Ankeny. The Defendant is also being charged with other sex offenses related to this case in Franklin County, and a sex offense in case 21-005383 where the victim's stepbrother is the victim in that case.
