I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime.

Between the dates and times listed above, the Defendant did knowingly and unlawfully commit assault with the intent to commit sex abuse upon the victim while inside a pop-up camper in the driveway/alley of the Defendant's office (114 3rd Street NE, Hampton, Franklin County, IA) when the victim was approximately 16 years old. The Defendant is the victim's step-grandfather. While laying next to the victim, inside the camper, the Defendant asked the victim questions related to masturbation and then told the victim that it was okay to "jerk off". The Defendant subsequently took out his own penis and began masturbating next to the victim. The Defendant then also reached out and attempted to touch the victim's penis but the victim was able to pull away.
