Narrative of Offense Committed
 On or about the above stated date and time, the Defendant did unlawfully and intentionally attempt to cause the death of the victim and not under circumstances which would justify the person's actions, the person does any act by which the person expects to set in motion a force or chain of events which will cause or result in the death of the other person

AFFIDAVIT

STATE OF IOWA, CASS COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 12/05/2021 at approximately 2351 hours, Officers were dispatched to the Cass County Hospital for a male subject that was stabbed. The victim said that he was at his residence located at Walnut Hills Terrace 1300 East 10th Street Apt. 26B when the incident happened. A physical altercation occurred in the apartment between the suspect and the victim.

Through the course of the investigation, it was learned that the victim was stabbed in the abdomen with a knife. This caused a serious injury that required him to be flown to a trauma center.

Through interviews and evidence obtained at and near the crime scene, a suspect was identified as Richard J Doss JR. Mr. Doss admitted to being in possession of a knife and being involved in an incident with the victim.

Mr. Doss is charged with Attempted Murder for stabbing the victim in the abdomen, an intentional act that would reasonably cause the death of a victim.
