AFFIDAVIT

STATE OF IOWA, POLK COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

Between the dates and times listed above, the Defendant did knowingly and unlawfully commit indecent exposure to the victim while in the living room at the victim's house ([REDACTED]) when the victim was approximately 12 years old. The Defendant is the victim's step-grandfather.

The Defendant just had surgery for a bypass where they went up through his groin. The victim was in the living room with the Defendant, who asked the victim if he wanted to see his incision. The victim said yes and the Defendant pulled the leg of his shorts over exposing his penis. The victim described it as "chode", short and fat, and circumcised. The victim said the Defendant would ask him about not being circumcised.

The Defendant started asking the victim about his masturbation habits and penis size once he hit puberty. The Defendant would wake up the victim by sitting on his bed, lifting up his shorts and asking him if he had morning wood. One of these times the Defendant touched the victim's penis. This occurred the summer between 7th-8th grade. The Defendant is being charged with sex abuse 3rd for this incident. The Defendant is being charged with other sex offenses related to this case in Franklin County and Dallas County. The Defendant is also being charged with indecent contact in related case 21-005383 where the victim's stepbrother is the victim in that case.
