On May 10th 2023, Burgess Hospital in Onawa, IA contacted the Monona County Sheriff's Office to notify Derek Webster Jr has arrived at their location seeking medical attention for a stab wound to the chest.

Monona County Law Enforcement arrived and spoke with Derek Webster Jr, which he stated he had been at a local bar and was jumped outside by a white male driving a motorcycle. Webster Jr's girlfriend, Inessa Lyons, was also present at the hospital and provided a similar statement. Webster Jr was transported to Mercy One in Sioux City, Iowa where he received treatment for his injury.

Monona County Sheriff Deputies and Special Agents with the Iowa Division of Criminal Investigation conducted a series of interviews and examination of the residence of 803 2nd St Apt 3 Onawa, IA. Throughout the course of the investigation Lyons provided additional details wherein she admitted to assaulting Webster Jr. Lyons stated Webster Jr had been harassing her to transport him to a store to purchase more alcohol, which after repeatedly denying his requests, stabbed him with a knife while both were in the kitchen area of the residence.

A further investigation determined Lyons had previously been convicted of voluntary manslaughter as a result of stabbing an individual.
