NARRATIVE

Narrative of Offense Committed

On or about the above stated date and time, the Defendant did knowingly resist or obstruct Chief Deputy Nathan Nickle, known to be a peace officer, emergency medical care provider or fire fighter, or a person performing bailiff duties pursuant to section 602.1303, subsection 4 in the performance of his or her lawful duty

AFFIDAVIT

STATE OF IOWA, RINGGOLD COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed his crime

State all facts and persons relied upon supporting elements of alleged crime

The incident occurred at the Poe Hollow Park East of Mt. Ayr. Deputy Nathan Nickle had a call of service earlier when he placed a package in his patrol vehicle. That package contained an improvised explosive device (Bomb). Deputy Nickle contacted the State Fire Marshal who informed him to take the device to a secluded area for safety. Deputy Nickle arrived at the Poe Hollow Park that was outside of Mt. Ayr and was a secluded area away from people. When he arrived at the gate to the park, the gate was locked with a padlock. Deputy Nickle contacted Kate Zimmerman to come to his location and unlock the gate so that he could move his patrol vehicle that had the device to a safe location inside the park. Zimmerman refused Deputy Nickle's order to unlock the gate. Deputy Nickle and Zimmerman continued to converse about unlocking the gate and allowing him to take his patrol vehicle that contained the bomb, inside the park where it was secure and away from people until the Fire Marshall arrived to handle the device. Zimmerman continued to refuse entry into the park.


