I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On August 8th, 2021 at approximately 10:44 PM, the Decatur County Sheriff's office received a 911 call from Kody Vogel. Vogel reported that he and Eggers had been shot.

The ensuing investigation determined that the defendant had shot at the vehicle Eggers was driving. Eggers and Vogel were both transported by helicopter to Mercy Hospital in Des Moines with potentially life threatening gun shot wounds.

During an interview of the defendant, the defendant admitted to shooting at a vehicle as it passed by his daughter's residence on County Road J-45. The defendant admitted that he fired two shots at the vehicle. The defendant told DCI Agents that he thought he was shooting at a vehicle driven by Chance Newton. The defendant admitted that he found out later that he had shot Eggers and Vogel.
